



## DCR Compliance Declaration Letter

This letter provides information in regards to Fairbanks Wire's due diligence to the Conflict Minerals Act relating to material purchased and processed into our wire products.

Fairbanks Wire purchases stainless steel, nickel alloy, and copper alloy rod from suppliers across the globe and converts the rod to product per internal and external requirements and specifications.

Fairbanks Wire has issued requests to our rod suppliers in regards to compliance to the Act. All suppliers have confirmed that the supply chain is in compliance with the Conflict Minerals Act under section 1502 of The Dodd-Frank Wall Street Reform and Consumer Protection Act and do not purchase any of the minerals whose origin is from the Democratic Republic of Congo (DRC) or adjoining countries.

The suppliers use a high percentage of scrap materials in their manufacturing processes. This scrap is bought on the local market. It is technically and logistically not possible to trace the origin of such scraps and therefore to guarantee they are all exempt from DRC or boarding conflict countries origin.

### REACH Compliance Declaration Letter

We hereby certify that Fairbanks Wire Corp. fully complies with all the related requirements of European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH):

1. Under the structure of the REACH regulation, Fairbanks Wire Corp. does not manufacture any products, articles, substances or preparations. Accordingly, we foresee no registration or pre-registration or authorization requirement for the product we supply.
2. With regard to the requirements of Article 33 of REACH: Duty to communicate information on substances listed in articles. We declare that none of the SVHC's (the Candidate List of Substances of Very High Concern) are present at our facility or applicable to the products we supply.
3. With regard to the requirement of Article 67 of REACH: A substance on its own, in a preparation or in an article, for which Annex XVII, contains a restriction that parts shall not be manufactured, placed on the market or used unless it complies with the conditions of that restriction. We declare that none of the substances in the Conditions of restriction are present in Fairbanks Wire Corp. products.
4. With regard to the REACH SVHC list dated January 16, 2018, requires the identification of Substances of Very High Concern contained in articles above the threshold of 0.1% w/w manufactured and marketed in the EU (legal Reference EC 1997/2006), we declare that none of the Substances of Very High Concern are manufactured or marketed in our products.

As REACH regulation is updated frequently, for the major changes afterwards, such as the addition of SVHC substances into Annex XIV and the addition of restricted substances in Annex XVII, Fairbanks Wire Corp. will evaluate in a timely manner and update this declaration to reflect these changes.

We further declare that all the statements in this letter are true and accurate. We are also aware that we will be liable for any direct damage incurred by your company arising from our breach of any declarations in this letter. The amount of damage shall be determined by an irrevocable judgment of competent and relevant authorities.
